**DOCKING PERMIT DECAL**

The Muskingum Water Conservancy District (MWCD) owns the lake. They require a Docking Permit for any boat moored in the water or kept on the club grounds. The decals are free for non-motorized boats under 15 ft. For boats over 15 ft on trailers, the annual fee is **\$150**; the fee for moored boats is **\$283**. The decals must be ordered through the Club. A copy of your current unexpired OH registration card is required. A current trailer registration is also required.

## **MEMBERSHIP RESPONSIBILITIES**

I understand membership in the Mohican Sailing Club is open to any person interested in the mission of the club as outlined in the Constitution without respect to gender, race, creed, religion, citizenship, national origin, political affiliation, sexual orientation, disability, or other biases.

I understand the club is a cooperative club in which all members are expected to contribute to its maintenance and its operation through participation in Dock and Undock Days and in other volunteer activities.

I understand my dues must be paid on an annual basis; failure to pay dues will result in the forfeiture of membership.

I understand that any boat that I leave on Club grounds overnight must have a valid, up to date OH registration and must have a current MCWD decal. These must be displayed on the watercraft by May 30 of the current year. Boats left on conservancy property (which includes the grounds that the Club leases from the conservancy) in violation of this rule will be considered abandoned and disposed of by Mohican Sailing Club in accordance with the Laws of the State of Ohio.

I understand that any trailer that I leave on Club grounds overnight must have a valid, up to date license plate. Trailers left on conservancy property (which includes the grounds that the Club leases from the conservancy) in violation of this rule will be considered abandoned and disposed of by Mohican Sailing Club in accordance with the Laws of the State of Ohio.
